

DOLLAR GENERAL RACE IN TO WIN SWEEPSTAKES OFFICIAL RULES

1. 3. TO PLAY: During the Promotion Period, there are three (3) ways to participate for a chance to win an Instant-Win Prize and to enter a random drawing for a chance to win a First Prize. To participate via (a) “Internet” or (b) “Toll Free”, you must have a Sweepstakes Transaction code (“Code”). How to obtain a Code: To receive a Code, visit any participating Dollar General store, during the Overall Promotion Period (during store hours), and purchase one (1) or more of the Qualifying Products (as listed in Appendix A of these Official Rules). Your Code will be the 15-digit Code appearing on the bottom of your checkout receipt (“Receipt”). Upon making a purchase of Qualifying Product(s), keep your Receipt. You will be provided with one (1) unique Code for your entire sales transaction, regardless of the number of Qualifying Products purchased.

(a) Internet: Go to www.dollargeneral.com (“Web Site”) and click on the Sweepstakes icon, banner or text link which will take you to the Sweepstakes page. Follow the on-screen instructions to properly complete a registration form in which you will be required to enter your full name, complete address, daytime phone number, date of birth, and email address and create a password. Once you have registered for the Sweepstakes, you will be prompted to enter your Code for a chance to win an Instant-Win Prize (a “Play”). The Sponsor will notify you via email within 24 hours informing you whether you have won a prize (subject to verification).
